PASTOR'S 2020 ANNUAL REPORT

February 21, 2021

You have heard me refer to 2020 as the year that didn't happen. That is because there were so many things we look forward to that did not happen. The Passion Play did not happen. The traditional Easter egg hunt did not happen. On Resurrection Sunday, one of the biggest Church feast days, we did not have public Worship. Services were held online only from late March until September. Weddings were postponed and special events were cancelled. Family gatherings and big birthday and wedding anniversary celebrations were postponed. Even funerals were delayed for a time in 2020, and some who experienced the sting of death of their loved ones had a difficult time finding closure. Yet, in these challenging and uncertain times, Shepherd of the Glades members and friends stepped up and did incredible ministry in Jesus' name. New Audio Visual equipment was purchased and our internet service received a much needed upgrade. We now have high quality weekly broadcasts on the internet. A matching fund challenge of \$10,000 was met and even exceeded \$22,000 to feed the hungry and provide shelter and assistance for those affected by the Covid virus. Worship attendance, giving, and participation in the life of the ministry of the Church actually increased. We closed the 2020 calendar year with a financial surplus. Thank you, and thanks be to God for all the amazing things "the year that did not happen" brought.

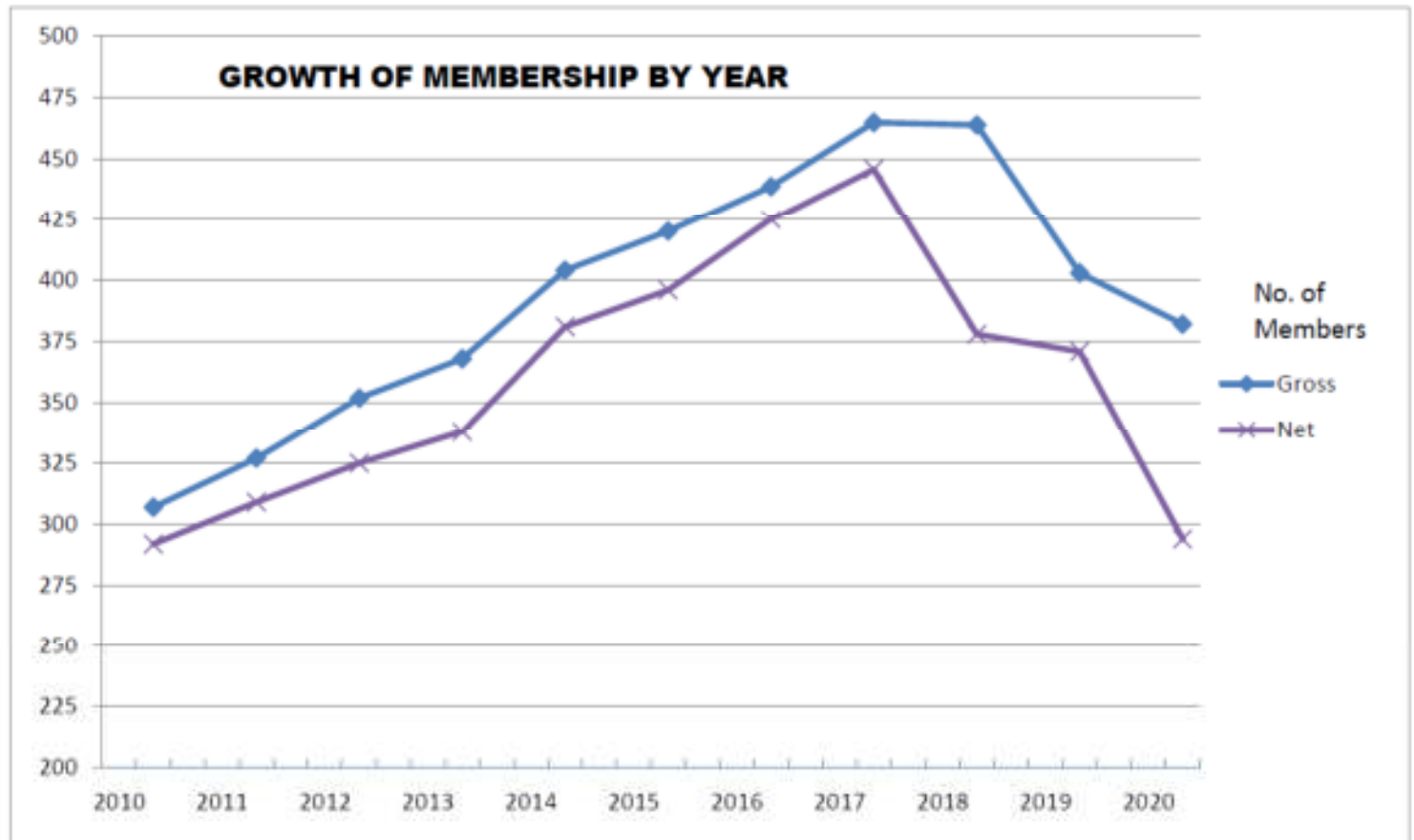
As I look ahead to 2021, the focus will be on our mission/purpose statement. "Transforming Lives through the Life Giving Word of God." This is a powerful, yet vague purpose statement. What is God calling us to do to transform lives in our Church and in our community? How are we transforming lives in this ministry we share as the body of Christ in this place? We recently added new AA groups that meet in Hanson Hall regularly. This has been a blessing in the lives of many people as they gather together to support one another in their efforts to overcome addiction to alcohol. Are there other support groups we are called to start or develop? How can we reach out to our community and neighborhood and help transform lives through our words and deeds? As we continue to grow as a congregation, it is my hope that we can begin planning additional staffing of a seminary intern or deacon. Shepherd of the Glades used to have 2 full time pastors and additional full time administrative staff. As we continue to grow in attendance and membership, I will need additional support. Shepherd of the Glades is currently an older congregation, and many are beginning to need Pastoral care in their homes. At the same time, we are getting new members who are wanting programming for Sunday School and outreach to new families. One minister (even this one!) cannot effectively grow the church and still give the attention current members deserve. The opportunities and possibilities in 2021 for transforming lives through the life giving Word of God are unlimited. I believe we can have an effective Capital Campaign and raise the funds needed to make long needed improvements while planning for growth and success.

As much as 2020 was the year that didn't happen, I predict 2021 will be the year we will see God doing amazing things if we are willing to follow God's life giving plan for Shepherd of the Glades and for us as members of the body of Christ. Thank you for an amazing call. It is a blessing and an honor to serve as Pastor of Shepherd of the Glades.

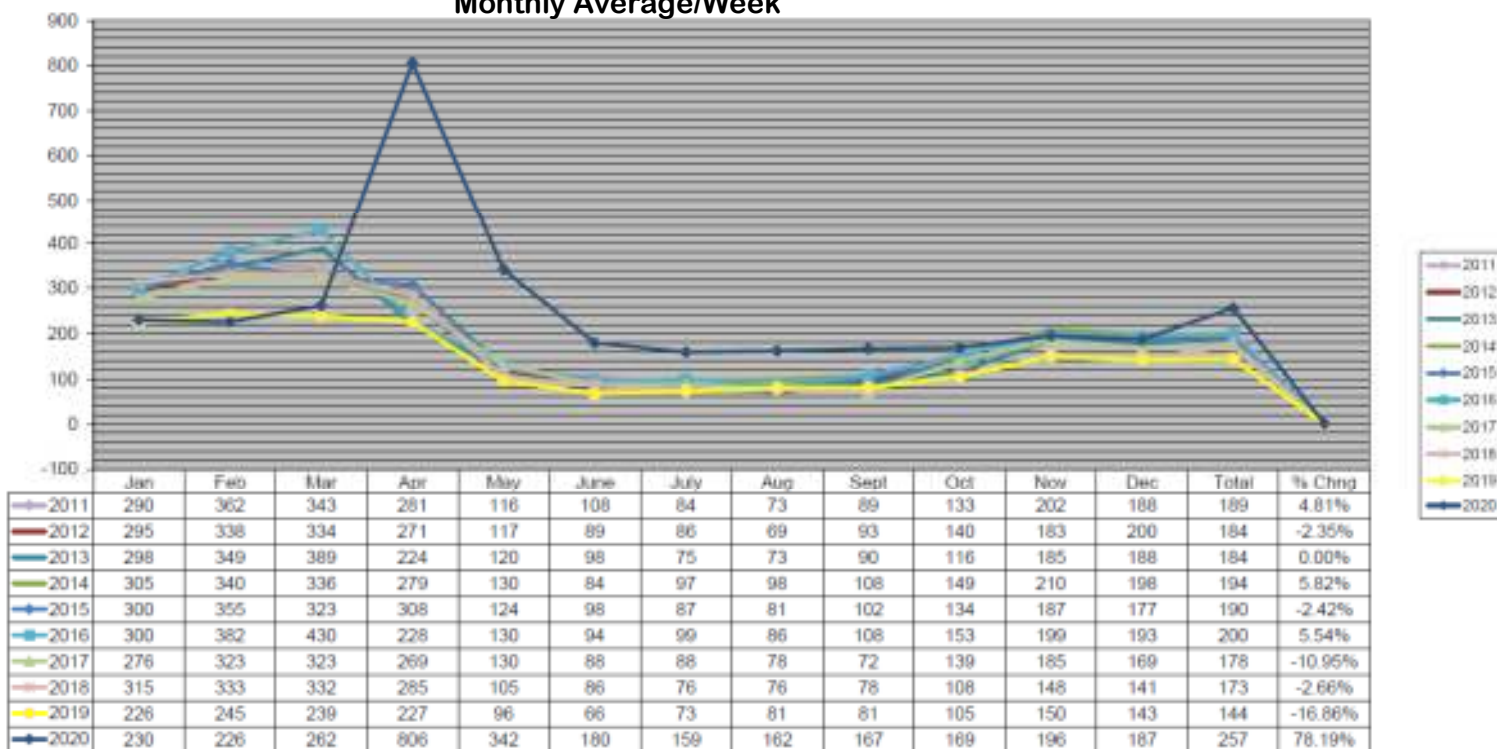

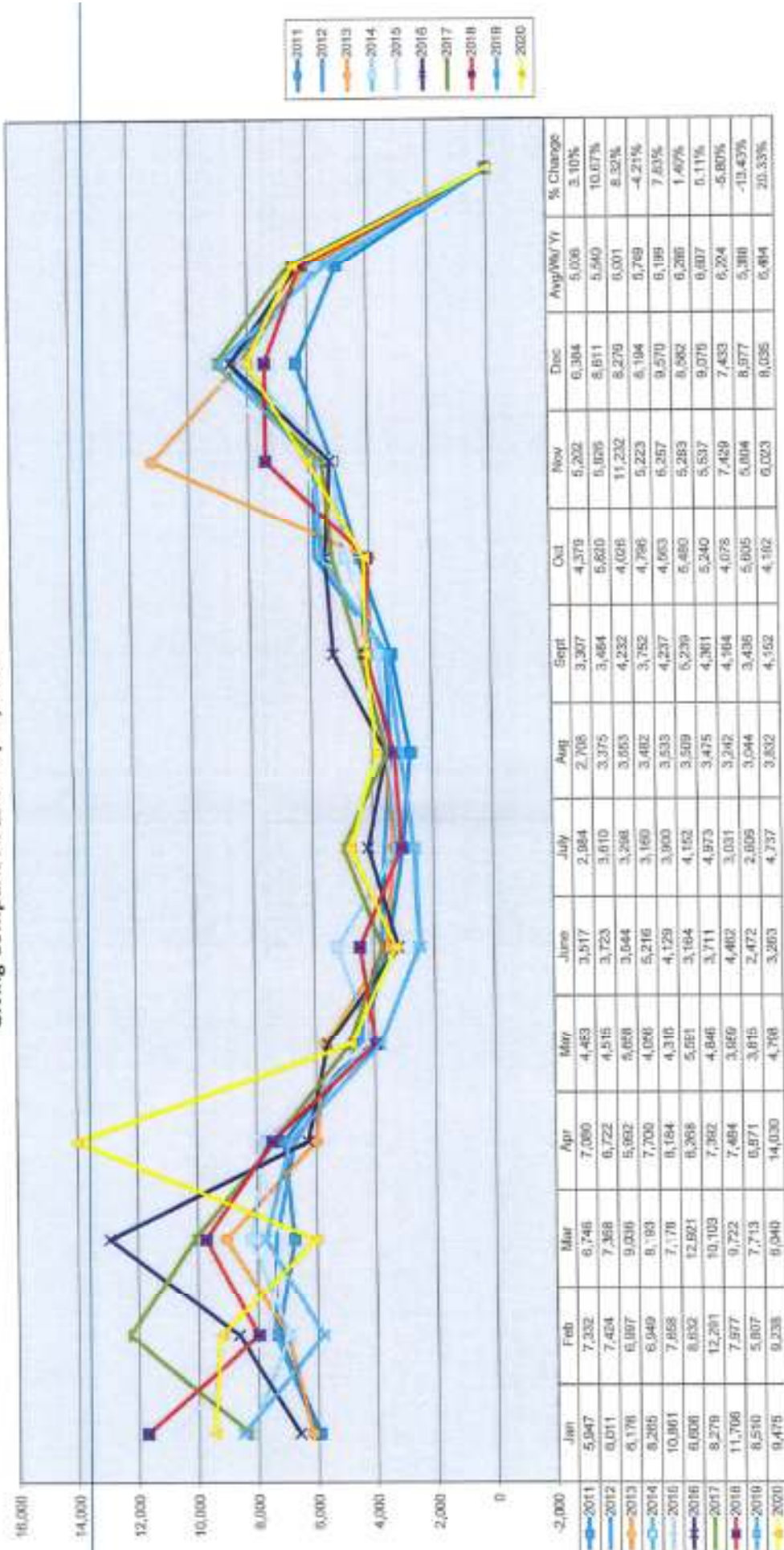

The Endowment Committee is responsible for receiving financial gifts beyond the current church budget, and distributing them as requested by the doner. When a specific request is not made for its use, then the gift is invested where principal is maintained and only the earned income is distributed. As of 1/1/2021 this fund had \$140,988 of which \$60,975 is available for distribution.

The objectives of this past year were to identify specific opportunities to enhance the mission of the church apart from the general operation of the church. This past year we have awarded a (\$5000./yr. for 2 years') grant for books and tuition to our seminary student Alisha Unga.

We have sent \$10,000 with the council's approval, to the Capital Improvement committee to be used as matching funds in their 2021 Capital Improvements Campaign. We have sent \$10,000 from the Memorial Fund, with council approval, to the Capital Improvements Committee to be used as matching funds for the upcoming Capital Improvements Campaign.

In 2021 we plan to continue making financial gifts as needs become known. We also plan to expand the diversity of this fund by awarding financial gifts to the needs in our community.

2020 Stewardship Report

Members of the Stewardship Committee: Dr. Bonny Dery, Mr. Dave Larson, Mr. Chuck Keller, Chair Person

The purpose of the Stewardship Committee is to raise the congregation's awareness of the need to promote stewardship at SOTG through the use of its time, talents, and financial resources.

"2020 Stewardship Vision" was the theme used to highlight our stewardship work at SOTG Lutheran.

On three consecutive Sundays in January, "Temple Talks" were given by Chuck Keller, Bonny Dery, and Dave Larson as part of Pastor Jeff's weekly sermon.

Chuck Keller introduced the theme for the year and the vision to achieve the goals. We used the A/V system to show how the 3 elements of stewardship can be part of our daily life.

Dr. Bonny Dery compared the components of our vision to the components of our spiritual life. Different styles of 2020 eyeglasses were given to congregants to aid in our "2020 Stewardship Vision."

Dave Larson spoke about the physical and spiritual gifts which were given and how we can use them in the future.

On Commitment Sunday, the congregation returned their Time and Talent information sheets and pledge cards. As of 2/3/2020, \$163,585 was raised with 57 pledges.

We were planning to focus on our "2020 Stewardship Vision" during the year by providing Temple Talks, articles in the newsletter, and stewardship A/V programs.
